- Certified copies of course certificates, transcripts of records or equivalent where it is stated at which university and when you studied, level, scope of credits and grade.
- Syllabus for the course/s in question
- For the courses in question, a list of literature, and where appropriate, degree project, have to be attached.

Local guidelines at Stockholm University for transfer of credits

Rules concerning transfers in accordance with the Higher Education Ordinance

Regulations concerning transfer of course credits etc., can be found in Chapter 6 Section 6 of the Higher Education Ordinance (1993:100). The regulations apply to studies at a first, second and third-cycle level. In accordance with these regulations, a student has the right to, under certain conditions, have credits transferred from a higher education institution other than that which they currently attend. Assessments concerning whether or not credits may be transferred are the responsibility of each respective university. The student is defined, in accordance with Chapter 1 Section 4 of the Higher Education Ordinance, as a person who has been admitted to, and is undertaking, higher education studies.

Local guidelines for the application of the rules at Stockholm University

- 1. A transfer of education is only to be done for someone who is a student at Stockholm University and thus, is admitted to, and is undertaking, studies at the university. This rule is to be strictly applied and a person who is not admitted to, or is undertaking, higher education studies, shall not have the possibility to obtain ECTS credits.
- 2. nducting higher education studies is defined as the student being registered to a course, and having obtained pass on a course consisting of at least 7,5 ECTS credits.
- 3. o called establishment of persons in the national student database (LADOK) for the sole purpose of enabling the entry of study results obtained outside of the university, may not be done.
- 4. The Vice-Chancellor has delegated decision-making authority to the faculty boards who in turn may delegate the authority within the faculty. These guidelines (Vice-Chancellor 20 May 2007, D-no. SU 451-1439-07 DocNr 1) come into effect on 1 July 2007 and replace previous provisions by the Vice-Chancellor concerning these matters (R 2004 06 10)
